Minutes of the Vestry Meeting

June 14, 2023

1. Opening

1.1 Prayer read by Father Shane opened meeting at 5:28pm

- 2. Matters of General Consent
 - 2.1 Brooke moves to accept the May Vestry minutes, Stacie seconds. May 2023 Vestry Minutes accepted with no changes.
- 3. Brandywine Homes Presentation- Jim Bruisick and Brett Whitehead
 - 3.1 Brandywine made a presentation on several options for housing opportunities on the church's property. Currently in the conceptual level. They repurpose properties In-Fill Development. There is a city rezoning coming up in the future.

4. Reports:

- 4.1 Rector's Report Rev. Shane Scott-Hamblen
 - 4.1.1 Father Shane shared that he has two mini vacations coming up. Dates: June 19-22 and August 11-18.
 - 4.1.2 Parishioner Paul Hoag needs rides to church. He lives in Irvine. Also, because Paul has no family, he has named St. Michael's in his will.

 - 4.1.4 Father Shane needs a secretary/administrative assistant. Parishioner Susan Leinberger has volunteered.. She has previous experience working for Steve Jobs at Apple. Wayne was consulted and he was worried that this would take hours away from him as the new person would do the bulletin. Louise and Brooke said there are plenty of things for Wayne to do

to keep his hours. Everyone agreed on Susan being offered the position.

- 4.1.5 Don Sheetz resigned from Building & Grounds. Shane suggested that Parry Popejoy may be a good replacement until next Vestry change. The benefit to having Parry is that he would do much of the work himself and not hire someone else to do it. Parry could not be on the Vestry because he has not been a member of the church for a year. Everyone agreed to have Parry handle Buildings and Grounds for the interim.
- 4.1.6 The flying of the Pride Flag was discussed. It is felt that the flag is a symbol of acceptance, inclusiveness, and love. After the previous sermons and the response, the flag will be put up and there will be no more talking about it. This situation was a learning experience for us. Other flags or symbolism will rotate to show fairness for all. There was a motion made by Louise, that we love our neighbor as and fly the Pride Flag. Steve seconded the motion. The motion was passed. A second motion was made by Louise. She proposed that we work together to make our Mission Statement by the end of Advent 2023. Brooke seconded the motion. The motion was passed.
- 4.1.7 The desk in Shane's+ office is too big. He found one on Facebook Marketplace for \$100. He asked if anyone mind if he purchased it and got rid of the big one.
- 4.1.8 Shane+ brought up that Brooke would like to be ordained. He discussed it with the diocese. We will need to form a discernment committee to determine if Brooke has a gift.  - 4.2.1 The Year to date income is over budget and the expenses is under. It was opposite for the month of May.
 - 4.2.2 The church's bank accounts were hacked to the tune of \$150,000 total. The accounts were frozen and new accounts opened. This was not our fault. It happened during the change from Union Bank to U.S. Bank. We have gotten back \$100,000 and there is still \$50,000 in limbo. We are on the road to recovery.

Stewardship Report

Pledge Income for June, 2023 versus June, 2022 was up by \$3,091, +25%.

Year to date, we have collected \$180,877, which is 64.6% of the Pledge Total Budget of \$280,000. This is better news than last month. Last month precipitous decline in pledge income stabilized at budget. This year we are still at 61 Pledge Units.

Other Income

Plate Offerings were \$494 for the month, versus a budget of \$330. Donations Non Pledge were \$2,623 versus a budget of \$830. Year to date we are at \$26,797 versus \$4,980 budget.

Parish Center Donations were down significantly because of no Harbor Day income. Was averaging \$10-15,000 per month. They were \$5,351 Actual versus \$19,480 Budget. Year to Date \$110,095 Actual versus \$116,880 Budget.

Summary

Pledge Income stabilizing at near budget level. Plate Offerings and Non Pledge Donations are up. Parish Center donations down in June due to Harbor Day not in session.
